John Rickard re-elected as a new Board Member

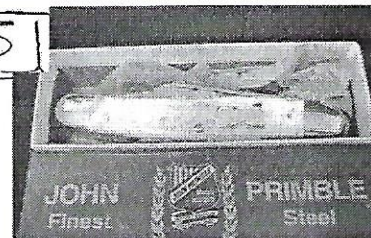
Steve Glenn elected as a new Board Member Ron Hounshell elected as a new Board Member.

Being a relatively new seller on this site, they offered me only PayPal to transact payments. That is fine since I have been a member of PayPal for several years and everything was fine. All of a sudden I receive this notice from PayPal:

Now I'm a straight forward and honest fellow. If I inadvertently did something wrong, then I would most definitely come forward to make it right. If I don't know what I did wrong, I can't correct it. I have talked to everyone at PayPal that will talk to me and they all will only quote the notice. I believe that if a person is accused of something they should have the opportunity to agree or deny the charge. I sure would like to have that opportunity.

That's my opinion. What is yours?

Oh, by the way, they are holding some funds of mine for 6 months!



After a review, we decided to permanently limit your account as we found potential risk associated with it.

You'll not be able to conduct any further business using PayPal.

Based on this decision, if applicable, you are no longer eligible for PayPal Seller Protection as per our User Agreement.

This will apply to all existing and future cases you receive.

Any bank or credit card information that's linked to your PayPal account cannot be removed nor can it be added to another account. You can still log in and see your account information but you can't send or receive money.

If you have funds in your PayPal balance, we'll hold it for up to 180 days. After that period, we'll email you with information on how to access your funds.

We regret any inconvenience this may cause.
